

## ABSTRAK

**EKO GURUH SANTOSO, NIM : E.1711071, Upaya Bhabinkamtibmas Dalam Pencegahan Peredaran Narkotika di Kalangan Remaja di Kabupaten Bogor, Skripsi, Program Studi Hukum, Fakultas Hukum, Universitas Djuanda, Bogor, 2023.**

Adanya penyalahgunaan narkotika di kalangan remaja di Kabupaten Bogor, telah menjadi kewajiban tersendiri bagi Kepolisian Negara Republik Indonesia (Polri) untuk memproses secara hukum penyimpangan terhadap peredaran narkotika dan berupaya mencegah beredarnya narkotika di kalangan remaja. Salah satu bagian dari fungsi kepolisian yang mendapat amanah tersebut adalah Satuan Bimbingan Masyarakat (Satbinmas). Tujuan penelitian ini adalah untuk mengetahui upaya Bhabinkamtibmas dan kendala yang dihadapi Bhabinkamtibmas dalam pencegahan peredaran narkotika di kalangan remaja di Kabupaten Bogor. Metode pendekatan yang digunakan dalam penelitian ini adalah pendekatan yuridis normatif. Teknik pengumpulan data dilakukan melalui penelaahan data berupa peraturan perundang-undangan, buku teks, jurnal, hasil penelitian, ensiklopedi, bibliografi dan indeks kumulatif dan lain-lain. Tahap penelitian terdiri dari penelitian kepustakaan dalam upaya mencari data sekunder dengan menggunakan bahan hukum primer, sekunder dan tersier. Disamping itu, dilakukan juga tahap penelitian lapangan untuk memperoleh data primer, sedangkan data dianalisis secara kualitatif. Hasil penelitian menunjukkan bahwa Upaya Bhabinkamtibmas dalam pencegahan peredaran narkotika di kalangan remaja di Kabupaten Bogor, yaitu melalui upaya preemtif, preventif dan represif. Kendala yang dihadapi Bhabinkamtibmas dalam pencegahan peredaran narkotika di kalangan remaja di Kabupaten Bogor, meliputi faktor masyarakat, keterbatasan sumber daya manusia, dan faktor sarana dan prasarana/fasilitas.

**ABSTRACT**

*The existence of narcotics abuse among adolescents in Bogor Regency, has become a separate obligation for the Indonesian National Police (Polri) to legally process irregularities in the distribution of narcotics and try to prevent the circulation of narcotics among adolescents. One part of the police function that has received this mandate is the Community Guidance Unit (Satbinmas). The purpose of this study was to find out the efforts of Bhabinkamtibmas and the obstacles faced by Bhabinkamtibmas in preventing the circulation of narcotics among adolescents in Bogor Regency. The approach method used in this study is a normative juridical approach. Data collection techniques were carried out through data analysis in the form of laws and regulations, textbooks, journals, research results, encyclopedias, bibliographies and cumulative indexes and others. The research phase consisted of library research in an effort to find secondary data using primary, secondary and tertiary legal materials. In addition, field research was also carried out to obtain primary data, while the data were analyzed qualitatively. The results of the study show that Bhabinkamtibmas efforts in preventing drug trafficking among adolescents in Bogor Regency, namely through preemptive, preventive and repressive efforts. Obstacles faced by Bhabinkamtibmas in preventing the distribution of narcotics among adolescents in Bogor Regency, include community factors, limited human resources, and facilities and infrastructure/facilities.*
